

miscalculation

(n.) the act of calculating something wrongly

e.g. There's a miscalculation on my salary deduction.



income tax

(n.) a part of your income that you have to pay regularly to the government

e.g. He pays income tax every month.

- I'm afraid there's something wrong with my payslip.
- I was wondering if my overtime hours are correct or not.
- I'm not sure whether my attendance record is accurate.
- It appears there's a miscalculation on my holiday pay.

Tips in Describing Issues or Concerns:

- 1. Clearly explain the issue.
- 2. Show evidence if necessary.

... Explaining the Issue/ Concern

- We truly apologize for the + (problem/ issue).
- ➤ Due to + (cause), we experienced + (problem/ issue).
- > We will (verb) as soon as possible.

Examples:

- We truly apologize for the confusion.
- Due to the system error, we experienced some slight miscalculations on your salary.
- We will review and correct them as soon as possible.

How to Explain an Issue or Concern:

- 1. Apologize
- 2. Explain the Cause
- 3. Provide a Resolution

.:: Common Types of Compensation


Base Pay
